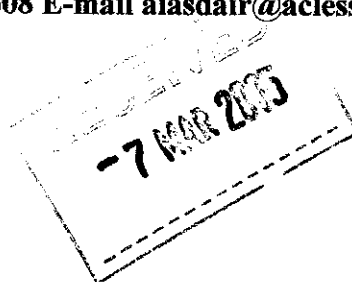

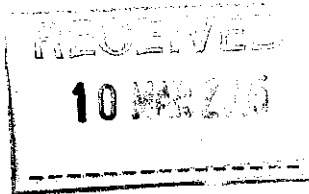

Just a short note to say thank you on behalf of the management team here at Balmoral Asset Management for assisting us in improving our Sage reporting package.

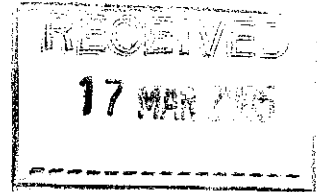
